- (i) The contractor should lift the old Newspaper, magazines and books at the end of the first week of every month.
- (ii) The contract will be for one year from the date of award of contract subject to the satisfactory service.
- (iii) The contract will be on weight basis. The Contractor has to bring the Platform Weighing Machine and not the Spring Balance Instrument for weighing the Old News Papers/Magazines.
- (iv) The weight of old newspapers, magazines and books will be taken in the presence of the Committee. The amount of the same will have to be deposited on the same day before issue of Gate Pass.
- (v) No transportation and labour will be provided by this office. The contractor shall have to arrange the same by himself. The gunny bags etc. will be arranged by the contractor.
- (vi) The contract will be as is where is basis.
- (vii) The contract will be awarded for a year. This office reserves its right to terminate the same at any time without assigning any reason.

One thousand only) in the form of FDR issued in the favour of this office as performance deposit which will be refunded after the contract is over. In case the services of the contractor are not found satisfactory, the earnest money will be forfeited and the contract will be terminated.

Interested parties may furnish their rates which will be valid for one year along with Ernest Money of Rs. 500/- (Rupees five hundred only) in the form of Demand Draft/ Bankers' Cheque drawn in favour of DDO, NMCC, Vigyan Bhawan, New Delhi. The quotation should reach the undersigned in a sealed cover on or before 12th August, 2007 up to 03.30 PM duly superscribed as "QUOTATION FOR OLD NEWSPAPER, MAGAZINES ETC' at the above given address. The Quotations received late will not be considered. **The quotations will be opened at 04.00 p.m. on the same day.**

The Council also reserves the right to terminate the contract at any time without assigning any reason therefor.
