**CIRCULAR**

Sub:- Filling up of one post of **Staff Car Driver** in National Manufacturing Competitiveness Council(NMCC) on deputation basis – reg.

1. Name of the post : Staff Car Driver
2. Scale of pay : Rs. 3050-75-3950-80- 4590/-
3. Age : upto 56 years
4. Educational Qualification : 10<sup>th</sup> Pass
4. Eligibility : (i) Holding the post of staff Car driver on regular basis in the parent cadre/department; or  
(ii) Class –IV employees in Central Govt. Departments having atleast five years LMV commercial driving licence or who have passed the driving test conducted by E&M Workshop, Safdarjung Airport, New Delhi and included in the panel of Drivers in their parent office and have two years experience in driving.

3. Appointment on deputation to the National Manufacturing Competitiveness Council(NMCC) will be governed by regular norms prescribed by the Deptt. of Personnel & Training from time to time. The persons selected for the post shall have the option to either draw the scale of the post of Staff Car Driver or his grade pay in the parent office plus Deputation (Duty) Allowance as per the existing instructions of the Department of Personnel & Training.
