2. The rates should be valid for a period of one year. The AMC will be initially for one year and can be extended on the basis of satisfactory performance of the Company. The batteries would be procured as per requirement of this Council from time to time during this period and there is no fixed number of batteries to be procured. Buy-back rates for disposal of old batteries may also be given.

3. The bidder approved finally for awarding the contract will be required to furnish a bank guarantee of Rs. 5000/- .

4. The applicant should submit the bids in sealed covers superscribed 'Quotation for AMC of UPS & supply for UPS batteries'.

5. The bids should be addressed to the Deputy Chief, Room No.236, Vigyan Bhawan Annexe, Maulana Azad Road, New Delhi. The last date for submission of the tenders is 7th July 2009 by 1500Hrs. The bids would be opened on the same day at 1600 hrs.

Terms & Conditions :-

1. The rates quoted shall remain in force for a period of one year from the date of awarding the AMC. No demand for revision of rates on any account shall be entertained during the contract period.
2. The Maintenance Engineer of the Firm should attend to the Complaint immediately on receiving the message. Corrective services as and when required including holidays, Saturday and Sunday must be undertaken on immediate basis.
3. The payments towards Annual Maintenance Contract shall be made in four installments at the end of each quarter on submission of bill.
4. All UPS will be repaired thoroughly by the firm in the Council. In case any UPS requires extensive repair in the workshop of the firm, arrangement for taking the UPS to the workshop and back will be made by the firm and this Council will not pay any transportation charges.
5. The EMD of the successful bidder will be kept in the Council till the end of the contract as performance security. The same will be returned to the firm after successful completion of the Contract.
